Terms and Conditions

RESERVATIONS:

A completed application and a \$500 deposit check are required to reserve a space. Full payment must be received 60 days prior to departure (90 days for Galapagos tours). Credit card payments are subject to a 3% fee.

CANCELLATIONS:

Cancellation fees are calculated as follows based on the date we receive your cancellation notice (please, send via UPS or FedEx).

Flights: Non-refundable

Non Galapagos Tours

- More than 60 days before departure – \$250*
- 59 to 45 days before departure - 50% of your trip costs*.
- 44 days or less to departure 100% of your trip costs*.

Galapagos Tours

- 125 days or more prior to departure: Deposit is non-refundable but can be applied to future cruise**.
- 124 to 71 days prior to departure: All deposits are non-refundable.
- 70 days or less prior to departure: Full payment will be applied as cancellation penalty.

* Higher if non-recoverable deposits/payments made by Highland Adventures exceed the fee amount. Including domestic flights.

** A future cruise is any departure, subject to availability, within 12 months of the original departure date. The applicable rate will be the one for the new cruise date.

TRAVEL INSURANCE:

We highly/strongly recommend the purchase of trip cancellation/interruption insurance to protect your travel investment.

REQUIRED DOCUMENTS:

A passport valid beyond your date of return is required. Peru, Chile, Ecuador and Argentina do not require visas from USA citizens. Those with other passports, please call the appropriate consular office.

PRE-DEPARTURE INFORMATION:

Upon registration you will receive a confirmation letter and a detailed package with recommended clothing, equipment list, and other information needed to prepare for the trip.

MEDICAL:

All participants must be in general good health. It is recommended to discuss any health concerns with your physician before your trip. Yellow Fever vaccine required if visiting Puerto Maldonado in Peru.

VOLUNTARY PARTICIPATION, ASSUMPTION OF RISK AND RELEASE OF LIABILITY

I acknowledge that I have voluntarily applied to participate on the trip designated on this application and that I have carefully read and understand the description, terms, conditions and recommendations of the trip in the enclosed itinerary. I am aware that adventure travel to remote areas like the ones visited in this trip, involves risks and dangers including but not limited to: the hazards of traveling in mountainous terrain, high altitudes, travel by raft, boat, plane, automobile, horseback or by other means of conveyance, or on foot; the forces of nature; civil unrest; terrorism; accidents or illness without access to means of

evacuation or the availability of medical supplies; the negligence (but not willful or fraudulent) on the part of Highland Adventures, Inc., its shareholders, employees, agents or others; or factors known or unknown. I am also aware that medical services or facilities may not be readily available or accessible during the time that I am participating in the trip.

I hereby accept and assume full responsibility for any and all risk of illness, injury or death. In consideration for being permitted to participate in this trip, I hereby for myself, my heirs, executors, and administrators; waive and release any and all claims that I may have against any and all persons affiliated with this event including but not limited to, event promoters and sponsors, Highland Adventures, Inc., its shareholders, employees, agents, or associates, arising out of, or in any way connected with my participation in the trip. I further attest that I am physically fit and I have prepared myself for the trip.

Rights and Responsibilities:

Highland Adventures, Inc. reserves the right to cancel any trip that does not reach a minimum level of participants to make it economically feasible for us to operate. We will inform you at least 45 days before departure. The refund for all moneys received shall be the limit of Highland Adventures, Inc.'s liability. Highland Adventures, Inc. is not responsible for any expenses incurred in preparing for a cancelled trip. Should tour(s) have to be cancelled due to circumstances beyond Highland Adventures, Inc.'s control (acts of God, flooding, fires, public unrest, acts of terrorism, etc.) Highland Adventures, Inc. shall offer at its discretion an alternative trip if practicable or refund all moneys paid less the initial deposit of \$500.
